**Announcement on the Resolutions of the

The meeting of the board of supervisors (the “**Meeting**”) of China Construction Bank Corporation (the “**Bank**”) was held onsite on 26 October 2017 in Beijing. The Bank issued a written notice of the Meeting on 16 October 2017. The Meeting was chaired by Mr. Guo You, chairman of the board of supervisors. 7 supervisors were eligible to attend the Meeting and 5 supervisors attended the Meeting in person. Mr. Jin Yanmin appointed Mr. Li Xiukun as his proxy to attend and vote on his behalf. Mr. Bai Jianjun appointed Ms. Li Xiaoling as his proxy to attend and vote on his behalf. Some of the senior management were present at the Meeting. The Meeting was convened in compliance with the provisions of the Company Law of the People’s Republic of China and the Articles of Association of China Construction Bank Corporation and other relevant rules.

The following resolutions were considered and approved at the Meeting:

I. Proposal regarding the Report for the Third Quarter of 2017

Voting results of the proposal: voted in favour: 7 votes, voted against: 0 vote, abstained from voting: 0 vote.
